(M.C.A.)
SESSION 2008-2009

2.1 GENERAL :

APPLICABILITY :

These rules shall apply to candidates seeking admission in first year of Three Years (Six Semester) MCA Course in institutions located in Chhattisgarh and which are approved by All India Council For Technical Education (AICTE), New Delhi given in Table 1

2.1.1 DEFINITIONS :

In these rules, unless it is repugnant to the context,

- (i) Chhattisgarh means Chhattisgarh state as formed on 01-11-2000.
- (ii) 'Category' means one of the four categories viz. 'Unreserved' (UR), 'Scheduled Caste' (SC), 'Scheduled Tribe' (ST) or 'Other Backward Classes (excluding creamy layer)' OBC.
- (iii) VYAPAM means Chhattisgarh Vyavsayik Pariksha Mandal .
- (iv) 'DTE' means Director of Technical Education, Chhattisgarh, Raipur.
- (v) 'Chhattisgarh Pre-M.C.A' means Chhattisgarh Master of Computer Applications Entrance Test-2008.
- (vi) 'Principal' means the Head of the institution.
- (vii) Chhattisgarh Seat means seat reserved for Chhattisgarh State Domicile Students. Requirements for Chhattisgarh State Domicile are defined from time to time by G.A.D. Chhattisgarh State. **Proforma 6 for Chhattisgarh domicile may be used.**
- (viii) Open seat means seats for Chhattisgarh domicile and all other candidates (domicile is not necessary).
- (ix) AICTE means All India Council for Technical Education-New Delhi.
- (x) 'CA' means competent authority declared by Govt. of Chhattisgarh.

2.2 SEATS AVAILABLE :

The names of the institutions and the number of seats available for admission are shown in Table-1&2.

2.2.1 SELF FINANCING AUTONOMOUS INSTITUTIONS:

Out of the total number of seats available for admission in each self-financing autonomous institution, 50% seats shall be reserved for candidates satisfying the Chhattisgarh domicile requirements as per rule 2.3.2. These seats shall be called, as "Chhattisgarh Quota seats". Remaining 50% seats shall be available for admission on All India basis, for which the domicile requirements are not necessary. These seats shall be called as "All India Quota seats".

2.2.2

RESERVATION OF SEATS:

Seats reserved for candidates belonging to Scheduled Caste (SC), Scheduled Tribe (ST) and OBC (excluding creamy layer) categories are shown in the Table-1.

Notes:

- (i) A candidate can claim reservation under a reserved category shall have to produce relevant certificate/certificates in Proforma 1or 2 given in this rulebook.
- (ii) A candidate claiming to be either of SC or ST or OBC category (excluding creamy layer) shall have to produce certificate from competent authority as described by Chhattisgarh State Govt. GAD Department. A permanent certificate from the Sub divisional Officer is to be produced . Certificate of the caste are to be verified from Scheduled Tribe Research and Training Institute Pt. Ravishankar Shukla University Campus, Raipur prior to the counselling.

2.2.3

RESERVATION FOR FEMALE CANDIDATES:

Under Chhattisgarh Quota seats of the Institutions in the self financing University institutions. 30% seats in each category viz. UR, SC, ST & OBC shall be reserved for female candidates. This reservation shall be horizontal reservation. Seats remaining vacant in female quota of a category shall be filled by converting such seats into open quota (Op) of the same category.

However even after this conversion the open quota (Op) of that category does not get filled then these vacancies shall be filled by converting them into open quota (Op) of such category as laid down in rule 2.5.10 of Chhattisgarh Pre MCA-2008

2.2.4

Reservation for PERSONS WITH DISABILITIES:

Three percent seats in each of the University institutions shall be reserved for those candidates who satisfy the domicile requirements as per rule 2.3.2 and are physically handicapped.

Candidates claiming admission against these seats shall be required to produce a disability certificate from District Medical Board and an eligibility certificate for the course from the Superintendent, Govt. of India, Ministry of Labour, Vocational Rehabilitation Center for Physically Handicapped, Napier Town, Jabalpur at the time of counseling. Both the certificates are compulsory.

2.2.5

The category class, Domicile etc. of the candidate as given in the result of CHHATTISGARH Pre-MCA declared by VYAPAM will not be changed under any circumstances at the time of counseling However candidate can get the relevant change made by VYAPAM as per Examination conduct rules .

2.2.6

PRIVATE INSTITUTIONS :

Table 2 shows the total number of seats in Private institutions. The number of seats for Chhattisgarh quota and All India quota will be declared at the time of counselling only those candidates who satisfy Chhattisgarh domicile requirements as per rule 2.3.2 shall be eligible for admission in Chhattisgarh quota seats. In all India quota seats Chhattisgarh Domicile students and students from other states will get admission according to merit

(Rank) of Chhattisgarh Pre-MCA Test-2008. Distribution of seats in Private Colleges is shown in table 2.

2.2.7 J & K Migrant's Quota Seats :

One seat in each of the Institution is reserved for Kashmiri Migrants. The reservation will be given on the basis of merit as decided by the entrance test. The candidate will have to produce a certificate as given in Proforma -7 by competent authority of J&K.

Sons/daughters of the employees of Chhattisgarh govt. who have served in the State of Jammu & Kashmir for curbing insurgency are also covered under the J&K migrant's quota. Such candidates should have passed their qualifying examination from the State of J&K. Candidates would be required to produce a certificate in proforma-8 of this rulebook at the time of counseling.

This reservation shall be over and above the sanctioned intake.

2-3

ELIGIBILITY FOR ADMISSION:

Educational Qualifications:

A candidate seeking admission to M.C.A. Course should be a Graduate of any recognized Indian or Foreign University or Institute recognized by the concerned University as equivalent thereto. The Bachelor's degree must be of minimum three years duration in any discipline with Mathematics as compulsory or additional subject at either (10+2) level or at graduation level.

Any allied subject of Mathematics (other than Mathematics or Higher Mathematics) at 10+2 level or graduation level is not acceptable.) Candidates who have passed examination of BCA course from any recognized University are exempted from the eligibility condition of having Mathematics as a compulsory subject at 10+2 level or higher level examination.

NOTE:

1. A candidate who is appearing or has appeared for final year of any degree examination during the current academic session as a regular or private candidate can also appear in the Entrance test on provisional basis. But such a candidate will have to produce the certificate of having passed the degree examination at the time of counselling.
2. Candidates placed in the compartmental/supplementary category in the result of final year degree Main examination of 2008 shall not be eligible for admission.
3. Candidates who have not passed graduation at the time of counselling will not be counseled .

2.3.1.

Age on 1.7.2008 Should not be more than 27 years .

There is relaxation in age of 3 years for reserved category and female students .

This relaxation under reserved category will be available to Chhattisgarh domicile student only.

2.3.2 DOMICILE REQUIREMENTS :

1. No candidate shall be selected for admission against Chhattisgarh seats in University or against the Chhattisgarh Seats in Private institution unless, he/she fulfills the requirements of the domicile of Chhattisgarh as defined by the Govt. of Chhattisgarh G.A.D letter. क्र. एफ 9-1/प्रस/साप्रवि/1-3 रायपुर दिनांक 17 जून 2003.
2. He/she is a son or daughter of an employee of the Govt. of Chhattisgarh or an officer of the all India services borne on the cadre of Chhattisgarh. A central

Govt. employee posted and stationed in Chhattisgarh on or before the date of admission. Proforma 4 & 5 may be used. However based on these proformas Chhattisgarh domicile certificate in proforma 6 is to be produced at the time of Counselling.

EXPLANATION:

GUARDIAN: Guardian in relation to a candidate means any person who in the opinion of the District Magistrate concerned, has after the death of his/her father and mother been in actual charge of or control over the candidate for his/her property or both at the time of application since the death of his/her father and mother. The certificate of guardianship from the appropriate court shall have to be produced as an evidence of guardianship. If the father of a candidate is dead but the mother is alive, she shall be deemed to be natural guardian of the candidate and no other person shall be recognized as guardian. Son or daughter shall also include stepsons or stepdaughters.

2.4 MODE OF SELECTION:

A Joint Entrance Test called Chhattisgarh Pre-MCA Test-2008 shall be conducted by, VYAVSAYIK PARIKSHA MANDAL Raipur Chhattisgarh for selection of candidates for admission to MCA course. The test shall have only one question paper containing questions from the subjects prescribed in the syllabus.

- 2.4.1 On the basis of the marks obtained by the candidates in Chhattisgarh Pre-MCA-2008 VYAVSAYIK PARIKSHA MANDAL Raipur shall prepare and notify combined merit list and category wise merit/waiting lists.
- 2.4.2 In case the marks obtained by Candidates are same, older in age will get higher placement in merit list.

2.5 ADMISSION PROCEDURE :

- 2.5.1 Admission shall be done through counselling on the basis of the merit list declared by VYAVSAYIK PARIKSHA MANDAL Raipur. The Counselling Committee shall be constituted by the competent authority, which will conduct the admission process.
- 2.5.2 The programme of counselling shall be published in leading newspapers of Chhattisgarh State. **CALL LETTERS WILL NOT BE SENT.**
- 2.5.3. A candidate coming for the counselling must bring profoma-9 (duly filled in) along with all the necessary certificates/ documents mentioned therein (in original along with a photocopy of each) and Bank Draft for Rs. 10000/- drawn in favor of “Additional Director of Technical Education, Chhattisgarh” payable at Raipur, towards the advance payment of fees. No advance payment of fees is required to be made by SC & ST category candidates of Chhattisgarh at the time of counselling. Hence they need not bring any draft. Candidates of General category Below Poverty Line need not bring Rs. 10,000/- D.D. as advance payment of Tuition Fee. But at the time of admission full amount of fee is to be paid to the institute.

- 2.5.4. Only one phase of central counselling will be organized by Directorate of Technical Education.
- 2.5.5. If a candidate fails to present himself/herself on the date of counseling due to hospitalization because of serious illness/ accident and is admitted in the hospital, then his/her guardian/parents may be permitted for Counselling, provided an authority letter to this effect is submitted by the concerned candidate. Also a Medical Certificate issued by the concerned CMO/Civil Surgeon has to be produced as a proof of illness and hospitalization. If later on it is found that the information provided by the candidate is wrong, then the admission is liable to be cancelled and the department may take punitive action against the concerned persons.
- 2.5.6. After having found to be eligible for admission, the candidates according to their merit shall select the seat/ institution out of the Seats/Institutions available at their turn.
- 2.5.7. After having selected the Seat/ Institution, the candidate will have to complete all the formalities of admission and deposit the bank draft for Rs. 10000/-(except SC/ST category candidates). The remaining amount of fees etc. shall be paid by them in the institution where he/she is admitted. All the candidates shall be required to pay the fees in the institution-as per the rules of State Govt. of Chhattisgarh as applicable to them on the date of admission.
- 2.5.8. If a candidate fails to present himself/herself for counseling or fails to produce the relevant certificates in Original in prescribed proforma, he/she will lose his/her chance of selection of Seat/Institution. However if documents are produced later on he/she shall be considered for counseling in which case he/she will be entitled to select the seat/institution available at his/her turn on that day. If a candidate does not turn up even on the last day of counseling, it will be deemed that he/she is not interested in taking admission and will thus forfeit the right of admission.
- 2.5.9. In Institutions, where there is no reservation for a certain reserved category the candidates belonging to such category shall be considered for admission as per merit as if they are under the unreserved category.
- 2.5.10. In case eligible candidates to the extent of reservation in any reserved category are not available, the vacant seats shall be filled by converting them into other categories as follows:
The vacant seats of ST category shall be filled by SC candidates. Similarly, vacant seats of SC category shall be filled by ST candidates. In case eligible candidates to the extent of reservation in both SC & ST categories are not available, the vacant seats shall be filled by OBC category candidates. In case eligible candidates are not available under these three reserved categories, in the above manner the vacant seats shall then be filled by the unreserved category candidates.
- 2.5.11. Once a candidate is admitted in a particular institution through counselling, no transfer of institution shall be permitted. However the candidate can seek admission against the drop-out vacancy in any other institution. The procedure for admission

against the drop-out vacancies is outlined in rule 2.5.14 before seeking admission against the drop out vacancy, the candidate will be required to get his/her admission cancelled in the institution where he/she was initially admitted. In case of cancellation of admission on the request of a candidate after allotment and before admission a deduction of Rs. 1000/- will be made by D.T.E. After taking admission if request for cancellation is made a deduction of Rs. 1000/- by D.T.E. plus additional deduction of proportionate fee and other proportionate tuition fee such as hostel fee and other fee will be made by the institution.

2.5.12 The last date for allotment of seats through centralized counselling shall be announced by the CA. After this date the casual or the drop-out vacancies in any institution shall be filled at the institution level, out of the candidates in Pre MCA merit list, before the last date of admission declared by the university.

For this Counselling, Head of the concerned institution shall announce and advertise the details of the vacancies and invite eligible candidates for admission on a fixed date and the admissions shall then be done through counselling as per rules in the presence of the representative nominated by the CA.

2.5.13 All admissions shall be completed on or before the last date declared by the concerned University. No admission shall be made after this date.

2.6. CANCELLATION OF ADMISSION :

If it is found that a candidate has succeeded in getting admission in any institution on the basis of false or incorrect information or by hiding relevant facts or if at any time after admission it is found that the admission was given to the candidate due to some mistake or oversight, the admission granted to such a candidate shall be liable for cancellation forthwith without any notice at any time during the course of his/her studies by the principal. In case of any dispute or doubt concerning admission etc., decision of CA shall be final.

2.7 MODIFICATION TO RULES/ PROCEDURES:

The State Govt. of Chhattisgarh reserves the right to amend any rule/ procedure for admission in the public interest and any modification so made shall be binding.

2.8 The State Government of Chhattisgarh shall be the final authority for deciding all questions of policy regarding selection of candidates for admission. If any question arises relating to the interpretation of these rules for admission, the decision of the State Govt. of Chhattisgarh shall be final and binding.

2.9 **Jurisdiction:** In the case of any legal dispute, Jurisdiction shall be limited to the courts of Chhattisgarh only.

3 Raging is prohibited in the institutions the Govt. of Chhattisgarh has promulgated an Act in this matter the fact of which is reproduced as below -

CHHATTISGARH ACT
(No. 27 of 2001)
THE CHHATTISGARH SHAIKSHANIK SANSTHAN ME
PRATARNA KA PRATISHEDH ACT 2001

An act to prevent ragging in educational institution in the state and for matters connected therewith and incidental thereto.

Be it enacted by the Chhattisgarh legislature in the fifty second Year of the Republic of India as follows:-

| Prohibition of ragging | 3. | No student of an educational institution either directly or indirectly or by any other means or any where shall commit or take part in ragging. |
| Punishment. | 4. | Any person who contravenes the provisions of Section 3 or attempts to commit or abets the act of ragging or takes part either directly or indirectly in ragging shall be punished with either of the description for imprisonment which may extend up to five years or with fine which may extend to five thousand rupees or with both. |
